

## PRELIMINARY RATING DISCLOSURE



Disclosure in accordance with the requirements of point 6 of Section D of Annex I of Regulation (EC) No 1060/2009: Initial reviews or preliminary ratings provided on entities or debt instruments by Cerved Rating Agency S.p.A.
